12.5. Results of PBT and vPvB assessment

Octamethylcyclotetrasiloxane (D4) fulfills the current criteria set forth under Annex XIII of the EU REACH Regulation for PBT and vPvB substances and was included in the candidate list of SVHCs. According to our knowledge of the state of the art, however, D4 cannot be compared with known PBT and/or vPvB substances.

The interpretation of the available data by the silicone industry reveals that scientific evidence obtained from field tests essentially points out that D4 does not lead to biomagnification in aquatic and terrestrial food chains.

In air, D4 is decomposed by naturally occurring processes in the atmosphere. D-residues which do not decompose in this way in the air are not expected to accumulate from the air in water, the soil or living organisms.
